

PRIVACY NOTICE FOR SENIOR SCHOOL PUPILS – KEY INFORMATION

Senior School Pupil Privacy Notice - Key Information

This notice contains the key information about **how** and **why** we collect your personal information and **what** we do with that information.

Personal information is information that identifies you and relates to you. For example, information about how well you are doing at School and any information that we need to take care of you. Photographs and videos of you also count as your personal information.

We encourage you to read the full version of our pupil privacy notice which is published on the School's website and can be found at https://www.thequeensschool.co.uk/privacynotices. You can also obtain a copy of the full privacy notice by asking your parents to contact the IT Director at School or by speaking to your form tutor.

The full version includes additional points, such as:

- your rights including what decisions you can make about your information;
- how long the School keeps your personal information; and
- the legal reasons we have for holding your information.

Our primary reason for using your personal information is to provide you with an education.

We set out below examples of the different ways in which we use your personal information and where that personal information comes from.

- Admissions forms give us lots of personal information. We get information from you, your
 parents, your teachers and other pupils. Your old school also gives us information about you
 so that we can teach and care for you.
- Sometimes we get information from your doctors and other professionals where we need this to look after you.
- We may need to report some of your information to the government (e.g. the Department for Education). We will need to tell the local authority that you attend the School, if you leave the School or let them know if we have any concerns about your welfare.
- We will share your academic and (where fair) your behaviour records with your parents or education guardian so they can support your schooling.

- (Year 12 and 13 pupils only). With your consent, we may use photographs or videos of you
 for the School's website and social media sites, for the School's newsletters, magazines or
 prospectus, and for use in the press, in order to show prospective pupils what we do here
 and to advertise the School. We may continue to use these photographs and videos after
 you have left the School
- **(Year 7 to Year 11 pupils only)**. With your and your parents' consent, we may use photographs or videos of you for the School's website and social media sites, for the School's newsletters, magazines or prospectus, and for use in the press, in order to show prospective pupils what we do here and to advertise the School. We may continue to use these photographs and videos after you have left the School
- We may use photographs of you for educational record keeping. We may continue to use these photographs and videos after you have left the School.
- We may use photographs or videos of you on screens within school, or on Planet Estream (the School's secure video facility). Planet Estream provides the facility to record or broadcast live School events. We may continue to use these photographs and videos after you have left the School.
- Sometimes we use photographs and videos for teaching purposes, for example, to record a
 drama lesson using Planet Estream. We may continue to use these photographs and videos
 after you have left the School.
- We publish our public exam results and university destinations, future events and sports
 fixtures on the School website, social media sites, in the School's newsletters, magazines or
 prospectus, and for use in the press, to tell people about what we have and will be doing
- We use CCTV to make sure the School site is safe. CCTV is not used in private areas such as changing rooms.
- We will send you information to keep you up to date with what is happening at the School. For example, by sending you information about events and activities taking place (including fundraising events) and the School newsletter.
- We will keep details of your address when you leave so we can send you information and find out how you are getting on.

You have the following rights regarding your information:

- Rectification of information held;
- Access to information held;
- Deletion of information in certain circumstances;
- Portability the transfer of information to you or a third party;
- Restriction of use of information; and
- The right to object to the use of information in certain circumstances.

These rights are explained in more detail in the full privacy notice, and IT Director can give you more information.
